

ADMISSION
M.A. (DAY) COURSE IN SANSKRIT
(SEMESTER SYSTEM) SESSION 2019 - 2020

It may please be noted that all admissions are provisional.

- I. **The Merit Lists given below are provisional and are subject to:**
 - **the fulfilling of the eligibility criteria as notified earlier.**
 - the verification of the equivalence of marks/degree from other universities to those of this university, where applicable.
 - correction in the merit position due to any error, if any.
- II. If at the time of counselling/admission and verification of marks, it is found by the university authority that
 - a student does not satisfy the eligibility criteria, and does not have **completed results up to and including 5th semester (or semester up to the Final semester) or Part-I and Part-II of Honours/Major course in the relevant subject**, s/he will not be considered for admission, even if he/she is provisionally selected for admission;
 - a student has provided incorrect information in his online application form, his/her application and offer of provisional admission shall be liable to be cancelled;
 - a student had entered incorrect marks in his/her on-line application form, his/her rank position in the selection/merit list provided below shall be revised and corrected accordingly on the basis of actual marks obtained in the examination concerned.
- III. **For any provisionally selected candidate, *increase in marks due to post-publication review/scrutiny after the closing dates of application for admissions to M.A (Day & Evening) Courses for the academic session 2019- 20, shall NOT be considered, and his/her merit position shall NOT be changed.***
- IV. SC/ST/OBC-A/OBC-B/PD quota as per State Govt. rules.
- V. No separate intimation will be sent to individual candidate.
- VI. Candidates are to take admission in one course of study only, even if their names appear in more than one course.
- VII. Candidates who have appeared at the B.A/B.Sc. (Honours) or equivalent final examination, results of which have not yet been published, may be given provisional admission, subject to the following conditions:
 - α. **at the time of counselling/admission the provisionally selected candidates will have to produce a certificate in the prescribed format ([click here](#)) that their B.A/ B.Sc Final Examination has been completed on or before June 10, 2019; such candidates will be required to submit the mark-sheet within 30th September 2019, failing of which their provisional admission will be cancelled. The migration certificate must be submitted subsequently within one year from the date of admission.**

- β. their provisional admission will stand cancelled if they fail to secure Honours in the B.A/B.Sc. or equivalent final examination, 2019.

Note:

- As per circular Nos. BC-16014/1/82-SC dt.06/08/1984 & BCD-1, D.O.12017/11/89-SCD(R.CELL) dt.09/01/1990 and letter No.1510-SCW dt.31/05/2007 from the Government of West Bengal, Scheduled Castes/ Scheduled Tribes of the states other than West Bengal are not entitled to get the benefit of reserved quota in Sanskrit institutions in West Bengal, unless they can produce a domicile certificate of 10-year residency issued by competent authority.
- The candidates who will be provisionally selected under the OBC- A and OBC- B categories must produce an OBC certificate (the date of issue of the certificate should not be earlier than June 2018) issued by the competent authority that clearly indicates (i) the category (A or B) they belong to; (ii) that they do not belong to creamy layer of the society, at the time of counselling/ admission.
- OBC-A and OBC-B candidates of the states other than West Bengal are not entitled to get the benefit of reserved quota in Sanskrit institutions in West Bengal, unless they can produce a domicile certificate of 10-year residency issued by competent authority.

VIII. Candidates will be required to bring the following at the time of counselling & admission:

- A print out of the on-line application.
- 3 (three) recent passport size photographs.
- Online payment receipt downloaded from SBI server after online payment.
- All original marksheets, certificates including SC/ST/PD/OBC-A/OBC-B certificates from competent authorities in the names of the candidates themselves, where applicable, are to be shown at the time of counselling for verification.
- The original madhyamik admit card/certificate (for age verification).
- Attested copies of all mark-sheets, certificates, madhyamik admit card/certificate are to be submitted at the time of admission.

- a certificate in the prescribed format ([click here](#)) that their B.A/ B.Sc Final Examination has been completed on or before June 10, 2019
- If the provisionally selected candidate has completed his/her graduation in 2018 or before: An affidavit that he/she is not registered in any other day-course anywhere/elsewhere ([click here](#))
- If the provisionally selected candidate is pursuing an MA day-course or its equivalent in another college/university: an affidavit that s/he will be de-registering from that day-course ([click here](#))
- Parents/guardian's income certificate issued by the employer with office seal for the employed person and for others by a gazetted officer.

IX. **Date and time of counselling and admission:** on July 10, 2019 at 11:00 am.

Venue: Prof. Anita Banerjee Memorial Hall (Ground Floor, U.G. Arts Building), Jadavpur University (Main Campus).

- X. If a candidate fails to appear on the specified date and time for counselling, the next candidate in order of merit will be considered for admission. The candidate absent on July 10, 2019, will also NOT be considered for admission against vacancy (if any) at a later date.
- XI. At the time counselling/ admission if any candidate fails to submit any above mentioned documents he/she will be allowed to submit the same within 3 (three) working days, else his/her admission will be treated as cancelled.
- XII. Classes will commence on July 15, 2019.
- XIII. The candidates admitted to M.A. in Sanskrit course should have at least 50% attendance of total classes held during 15.07.2019 – 23.07.2019, failing which his/her studentship will be treated as cancelled without further reference.
- XIV. Vacancies, if any, along with names of waitlisted candidates will be notified on the website on 30.07.2019 after 6:00 pm. Only those candidates who were present at the time of counseling on July 10, 2019 and recorded their attendances at the Office of the Dean and Secretary, Faculty Council of Arts on the same day will be considered for admission against vacancy, if any.

Jadavpur University has accepted in principle that each and every student of the university shall be duty bound during the entire period of studentship with the university to immediately report to the Dean of Students if any ragging is noticed either in university hostel or on university campus.

If any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him/her from the university.

Details of on-line submission of anti-ragging affidavit shall be made available by the Head, Department of Sanskrit, at the time of counselling.

Print out of the anti-ragging affidavit submitted on-line by the student and his/her parents

must be submitted to the Head, Department of Sanskrit within 15 (fifteen) days from the commencement of classes (i.e., August 1, 2019).
